Reporting Responsibility: This position reports to the Chair of the Pharmaceutical and Biomedical Sciences Department for the College of Pharmacy.

Qualifications:

- Ph.D. in pharmaceutics, pharmacology, toxicology, physiology, immunology, or related pharmaceutical/biomedical sciences field.
- Postdoctoral experience and strong academic credentials in the discipline of pharmaceutics, pharmacology, toxicology, physiology, immunology, or related pharmaceutical/biomedical sciences field.
- Strong track of record for pharmaceutics and biomedical research and grant application.

Duties and Responsibilities

This position heavily focuses on research (more than 50% of the effort). Specific responsibilities for faculty in pharmacology include, but not limited to:

- Team up with the senior researchers to continue pharmaceutical and biomedical research and grant applications.
- Teach Pharm.D and graduate students in areas of pharmacology, physiology, pathophysiology, toxicology, immunology and/or topics related to pharmaceutical/ biomedical sciences as expertise. The teaching work is assigned by the Chair of the Pharmaceutical and Biomedical Sciences Department.



- Develop and improve the courses as expertise.
- Maintain publications and other scholarly activities.
- Serve committees of college of pharmacy and university as assigned.
- Assist the college with accreditation and regulatory processes.
- Assist the college and department with strategic plans and assessment.
- Participate in department, college, and university activities as assigned or needed.
- Advise Pharm.D students as assigned by the college.
- Advise graduate students as expertise.
- Mentor faculty as requested.
- Act as a professional model to students.
- Act as an effective representative of the college to the university and professional organizations.
- Work with Dean and accreditation team in all aspects of functions and activities including, but not limited to gathering & presenting data relevant to demonstration of compliance with accreditation standards.
- Collate student and faculty research activities, publications, grants, and other research activities relevant to demonstrate student & faculty research of the accreditation standards.
- Other duties as assigned.
